CHALLENGE

Carne Group was undertaking a major ICT transformation initiative. Their goal was to build a "workplace of the future"—a work environment supported by a resilient, cloud-first infrastructure.

Carne's global presence and regulatory obligations demanded a highly robust and compliant IT infrastructure. They needed a network solution that would deliver the following critical requirements:

- Always-on VPN access for a distributed workforce
